POLICY

To establish a program to provide a municipal portion tax rebate to business in the Village of Ryley within the C1 and C2 districts.

PURPOSE

The intent of the program is to provide monies back to businesses so that they may do work to enhance the curb appeal of their business and make the Village of Ryley a more aesthetically pleasing community.

Although not enforced it is encouraged that the rebates be hand delivered with comments to the above.

Although not enforced it is encouraged that the following years rebate cheques be hand delivered and that a verbal understanding of how the previous year's monies were spent is reviewed.

APPLICATION OF THIS POLICY

Yearly, an application form is sent to the business within the C1 and C2 districts that have a "store front" operation. The application form is attached to this policy and forms a part as schedule A.

Yearly, business are permitted, once their taxes are paid, to apply for the Village of Ryley Tax Rebate Program using the form provided.

Business that are not assessed for the purposes of taxation as exempt or non-profit are eligible.

The rebate value is set at 50% of the municipal portion of the property taxes to a maximum of \$2,000.

Appeals may be made to the Council of the Village of Ryley in a written form. All decisions of Council are final.

FUNDING

Funding for the program is to be done from the receipt of taxes generated.

RELATED DOCUMENTS AND LEGISLATION

Schedule A Village of Ryley Business Tax Rebate Program.

DEFINITIONS

C1 and C2 are the land uses as listed in the Land Use Bylaw.

"Store front" is a business that permits customers to enter the premises and do business.

Municipal portion of taxes are those that are not for school, seniors, or other purposes.

DUTIES AND RESPONSIBILITIES

Council will ensure that there are monies in the budget to support the program.

Administration will provide a copy of the Village of Ryley Business Tax Rebate Program to business considered eligible when tax notices are sent out.

Administration will monitor the uptake of the program.

Administration will provide any written concerns to Council for adjudication.

Council will adjudicate all written concerns in relation to the program.

Program

The Village of Ryley has developed a Business Tax Rebate program to support operational business in the community and to assist in offsetting the non-residential municipal portion of their property taxes.

Eligibility

Business in the boundaries of the Village of Ryley that pay commercial taxes and operate out of a C1 or C2 district.

Businesses that have a "store front" operation permitting customers to enter their establishment.

Businesses that are not assessed for the purposes of taxation as exempt or non-profit.

Businesses that if they do not own the premises that they operate out of can show that taxes are paid through triple net or some other type of agreement.

Business that receive multiple tax notices from the Village because the business property includes more than one (1) roll number, will have the total of all notices summed up, then the set rate will apply.

Business are only eligible once full payment of that years taxes are received by the Village.

Application must be received by the Village of Ryley by October 31, ———-.

Rebate Value

Rebates are available at a rate of 50% of the municipal portion of the property taxes to a maximum of \$2,000.00.

Appeals

Appeals may be made to the Council of the Village of Ryley in a written form. All decisions of Council are final.

RECOMMENDED ACTION

That Council for the Village of Ryley provides second reading of Bylaw 2018-10-16, a bylaw to amend the Intermunicipal Development Plan (IDP).

OR

That Council for the Village of Ryley continue to wait until the Municipal Development Plan (MDP) is mature enough to understand whether the two plans reconcile.

BACKGROUND/PROPOSAL

First reading was achieved through resolution 2018-11-06 #8. A joint public hearing was conducted with Council of Beaver County on November 13, 2018.

Although Beaver County alleges that Ryley has delayed this bylaw due to stormwater and flooding concerns on behalf of Ryley, this is not true. The IDP Amendment was agreed to be set aside at the Intermunicipal Meeting (IMC) of June 12, 2019 so that other urgent ICP items could be addressed and concluded. It was agreed that the current IDP sufficed for the ICP so the amendment could be addressed later.

Further, Ryley's delay on this bylaw has been to ensure our MDP coincides. Changing CAO has exacerbated this delay. Held in abeyance by the new CAO for Ryley while an understanding and reconciliation with the developing MDP could be gained, and given the decision to park the IDP Amendment at the IMC, the new CAO had not recognized the urgency that Beaver had toward this IDP Amendment.

It is of extreme high concern and urgency by Beaver County that Ryley provide readings and pass this bylaw so that the Amended IDP can be reconciled with the Equity Industrial Park, Area Structure Plan (EIP ASP). Specifically, Beaver County will not negotiate with Ryley on any issue until this amending bylaw is passed.

Administration has reviewed the IDP Amendment and considers it very positive and advantageous to adopt because of outdated issues in the active IDP. The risk of non-reconciliation with the MDP at this stage of development for both plans (documents) is very low because the planning differences affect long-term future results (10-20 years) that are likely farther out in time than review schedule of the next three years for the plans.

BYLAW NO. 2018-10-16 AMENDMENT TO INTERMUNICIPAL DEVELOPMENT PLAN

A BYLAW OF VILLAGE OF RYLEY IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING BYLAW 2008-882 BEING THE VILLAGE OF RYLEY / BEAVER COUNTY INTERMUNICIPAL DEVELOPMENT PLAN

WHEREAS, Section 631(1) of the *Municipal Government Act*, Chapter M-26 of Revised Statutes of Alberta 2000 (Act), authorizes two or more Councils to each pass a Bylaw to adopt an Intermunicipal Development Plan;

WHEREAS, Council previously adopted the Village of Ryley/Beaver County Intermunicipal Development Plan Bylaw 2008-882;

WHEREAS Section 191 of the Act, authorizes the Council of Village of Ryley to amend an Intermunicipal Development Plan to address future land use within the municipality;

WHEREAS Sections 632 and 633 of the Act, requires that all statutory plans adopted by the Council of Village of Ryley be consistent with other statutory plans;

WHEREAS, Council deems it desirable to amend the Village of Ryley/Beaver County Intermunicipal Development Plan Bylaw 2008-882;

WHEREAS, notice of the proposed Bylaw and Public Hearing was given pursuant to Section 692 of the Act;

NOW THEREFORE, the Municipal Council of Village of Ryley, duly assembled, hereby enacts as follows:

- 1. The Village of Ryley/Beaver County Intermunicipal Development Plan Bylaw 2008-882, shall be amended as follows:
 - a. Delete Section (G) Land Use Policies; Subsection (4), Subclause (ii), and replace with the following:
 - Subdivision and development of those areas identified for general industrial, commercial and light industrial activities shall include those uses identified and meet the regulations stated, within the Beaver County Land Use Bylaw.
 - b. Delete Section (G) Land Use Policies; Subsection (4), Subclause (iii).

c. Delete Section (G) Land Use Policies; Subsection (4), Subclause (iv), and replace with the following:

Subdivision and development of those areas identified for landfill and related uses shall include those uses identified, and meet the regulations stated, for the Landfill and Composting District within Beaver County's Land Use Bylaw.

d. In Section (G) Land Use Policies; Subsection (4), insert the following after Subclause (iv):

Subdivision and development of those areas identified for industrial park activities shall include those uses identified and meet the regulations stated, within the Equity Industrial Park Area Structure Plan and Beaver County's Land Use Bylaw.

- e. Schedules "B", "C" and "D" shall be deleted.
- f. Maps 1 and 2 shall be deleted and replaced with Maps 1 and 2 in Schedule A attached and forming part of this bylaw.


Map 1 – Plan Area Boundaries

Aaron has been forwarding your conversation onto me. As the lead on the IDP portion of the ICF/IDP project, you can use me as the primary point of contact, but I encourage you to continue copying Aaron as he serves in a deputy capacity and can do his best to move things along if and when I am temporarily distracted. It is my understanding that the Steering Committee meeting mentioned below is for the MDP and that ISL is not being asked to attend. Rather, your two parties are committing to add this item to your agenda for this meeting. Note I have copied Margaret Jones of the County on this email to bring her into the loop as she is the project lead on behalf of the five municipalities and it was Bob Beck that was in attendance for Wednesday's IMC meeting between Ryley and Beaver County.


Al – thank you for reaching out to lan and introducing the two parties.


It is our understanding through you and your councillors that, among other things:

- the MDP project is moving forward concurrently, with a completion date likely occurring after the IDP adoption;
- the southern half of SE-9 (see first image below) in the Village is impacted by the legislated landfill buffer and even future industrial development could be prohibited within that buffer;
- the eastern portion of SW-9 outside of the Village (identified for future urban residential expansion in the IDP) is also impacted by the legislated landfill buffer;



- the MDP is visioning future growth directions outside of Ryley that may not align with the land use vision of growth directions previously identified in the IDP (see second image below) in particular, extending future urban residential westward into SE-8 (partly due to the landfill setback restriction on SW-9) and redesignating SW-4 and SE-4 from future urban residential to future urban industrial; and
- while no area structure plans (ASPs) are in place in Ryley, preparation of two outline plans is underway, and if deemed viable may be elevated as ASPs.





If the MDP visions the differences noted above for Ryley's future urban expansion beyond its current boundaries, we're glad to see the endeavor to get the Village's committees on both the MDP project and the IDP update project up to speed on each other's projects. If the IDP committee shares the vision of the MDP committee for future expansion outside current village boundaries, we suggest the Village engage in discussion with the County in accordance with s.636(1)(d) of the MGA as soon as possible, at least on the matter of the future urban expansion vision. This would enable opportunity to build consensus between the two municipalities and ultimately achieve consistency between the two statutory plans as required by s.638 of the MGA.

lan – nice to connect with you. Please advise of your team's timing on a future land use concept for the Village's MDP. We've made assumptions on the future use of undeveloped lands within the Village in the absence of an adopted MDP in effect and would like to ensure accuracy in our land supply mapping and analysis for estimating future land consumption.
