

CAO's Corner:

HELLO RYLEY!!!

I read some posts on our local social media recently and they brought me great disappointment. I am appalled by some of our local citizens when they engage in inappropriate language and personal attacks in a public forum. I find this especially disturbing because our community's youth are also on these platforms and we adults should be positive role models. I enjoy some public challenge and critical questions – these are healthy, and they motivate interaction and discussion. They keep our community communicating and inform us all on what we as a community group think and feel. However, personal attacks do not belong in our community and none of us need such disrespect.

What is the Village Staff up to? Firstly, as much as we would like to greet you in person, we have decided it is safer to keep the office door locked for just a while longer. Most of the staff are working at their desks inside while keeping a COVID safe social distance and furiously wiping and cleaning often to keep the building sterile. A few of the staff have health concerns that bring a higher threat for COVID exposure, so when we open the office to the public, we will need to spend significantly more time and energy on additional cleaning and health protocols. That will take time away from our primary duties in serving you. I believe that we have an exceptionally good system of telephone response and we can continue to physically respond to any of your municipal needs. If you call the office and get the answering machine, please leave a message - we are answering the phone during normal work hours and we are checking messages all the time, even remotely when we are not in the office. We are at work and are fully serving you.

I have good news and bad news: the good news is that we received a grant to conduct an engineering study so we can build proper drainage to end our incessant flooding throughout Ryley. This study will take two years so the bad news is that we must hold our breath for just a bit longer. In the meantime, we have placed a high priority on removing puddles, swamps and lakes by clearing out some of the present drainage systems and creating some temporary extra ditching and swales. What this means to you is that, while we focus on the big water to start drying up Ryley to decrease those sewer backups and road degradation, our focus on some of the other Village maintenance may be delayed just a bit. I ask for your patience as the Public Works Staff is working on systemic priorities that will make bigger difference in the long run. That said, if you do feel that something must be addressed, please

call the office and we will investigate it immediately. I am working with Council to consider a bold budget this year. This is taking time while they carefully consider and establish our priorities for the year. What we do know is that 54 Avenue must be replaced because the sewer pipes underneath 54th are failing and will not make it through the next winter without severe impact to those residents. This will be our biggest expenditure of the year. The weather has finally warmed up enough so last year's project on 52 Avenue between the school and the trailer park is being paved by the time this hits your mailbox (or very shortly after). The ground-breaking ceremony on our Ryley Solar Power project is on Wednesday 10 June, out by the lagoon: the time is to be confirmed but we are looking at 10 a.m or 2 p.m. We are on track to energize by August. Watch our website for progress. Finally, we are aligning priorities to focus on your recreation and amenities, on how to stimulate business and economic development and of course, on what we should do as a community about the future of our Ryley Students.

Public Works is fighting a huge battle on alleys. Last summer's flooding and this winter's frost heaving has destroyed them faster than we can keep up with and now the heavy equipment such as garbage trucks are beating them up badly. Again, please be patient as we work on the strategy of diverting stormwater to allow a deeper drying out of the ground beneath our alleys to firm them up before we start remediation.

You are probably baffled by all the statistics in the news on COVID-19 cases. I found this graph which gives us a good sense of what is happening out there. Alberta is recovering very well, but we need to keep safe by continuing to be diligent. The protocols remain the same: keep your six (6) foot distance from each other, wash your hands often, clean surfaces often and keep your hands away from your face. Remember that sun, exercise and fresh air strengthen your immune system, so I encourage you to get out and go for walks.

Haiti Rebuilding Fundraiser

Margaret Jones is coordinating another FREE fundraiser for her team's house-building project in Haiti next year. This fundraiser is unique because it is a winwin-win-win for everyone. It's called a FUNDrive and it's a partnership with Value Village. Here's how it works: **WIN FOR YOU** – you bag up used clothing, shoes, textiles (e.g. towels, sheets, pillows, etc.), housewares, toys, and books. Deliver the items to the Library (when it reopens) or to Margaret's house (in the collection bin beside the driveway) and she will recycle them for you, free of charge.

WIN FOR THE ENVIRONMENT – keep your unwanted items out of the landfill and reduce your carbon footprint. Did you know that every year, 26 billion pounds of clothing and textiles go to the landfills - 95% of which could be reused or recycled? Through Margaret's last 2 FUNDrives, 7.5 tons of used items were diverted from the landfill.

WIN FOR VALUE VILLAGE – they receive new inventory to support their business objectives, including providing employment, recycling unsold items to developing countries, and supporting charities.

NOTICE OF PUBLIC HEARING VILLAGE OF RYLEY (the "Municipality") IN THE PROVINCE OF ALBERTA PROPOSED RESOLUTION REGARDING BEAVER MUNICIPAL SERVICES (BMS):



• That the Village of Ryley has considered on May 5, 2020 the business plan adopted by Beaver Municipal Services (the "Business Plan") and has approved the contents of it, in consideration of the decision in order to cause a corporation, to be called "Claystone Waste Ltd.", (the "General Partner Corporation") to be incorporated pursuant to the Business Corporations Act, which General Partner Corporation will act as the corporate entity to operate the registry office, and

• That the Village of Ryley provides its notice of intention to hold a public hearing on Tuesday 16 June 2020, as required by Sections 75.1, 75.5, 230 and 606 of the Municipal Government Act and Section 3 of the Municipally Controlled Corporation Regulation, prior to causing the General Partner Corporation to be incorporated.

To be held June 16, 2020 at 7:00 pm in Ryley, Alberta

PURSUANT to sections 75.1, 75.5, 230 and 606 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended and Section 3 of the Municipally Controlled Corporation Regulation, A.R. 112/2019, the Council of the Municipality, in the Province of Alberta hereby gives notice of its intention to incorporate and control a corporation pursuant to the Business Corporations Act.

THE PURPOSE of the proposed Resolution is: 1. Beaver County, Town of Tofield, Town of Viking, Village of Ryley and Village of Holden are the sole members of the Beaver Regional Waste Management Services Commission also known as "Beaver Municipal Solutions", (the "Commission");

2. The Commission and the five municipal members, including the Municipality, wish to corporately reorganize the Commission, by transferring operations over to the proposed Claystone Waste Limited Partnership (the "New Waste Provider"), with these five municipalities being the sole partners in the New Waste Provider; 3. As the New Waste Provider is a limited partnership, a new municipally controlled corporation shall be created pursuant to the Business Corporations Act ("BCA") to act as the General Partner of the New Waste Provider, to be called Claystone Waste Ltd. (the "MCC"). The same five municipalities will also be the only shareholders of the MCC;

4. The Municipality wishes to be a shareholder and jointly create and control the MCC under the BCA; 5. 6. The Council of the Municipality wishes to comply with all obligations under the MGA and the MCC Reg to cause the MCC to be incorporated.

DURING THE COVID-19 PANDEMIC, the Government of Alberta has enacted the Meeting Procedures (COVID-19 Suppression) Regulation pursuant to Order in Council 099/2020 (the "COVID Regulation") to permit for electronic hearings to be held instead of in person hearings, in light of the global COVID-19 pandemic; THE FOLLOWING INFORMATION will be disclosed at the public hearing:

1. the services the corporation and the New Waste Provider intends to provide;

2. the names of the five municipalities who will be the shareholders of the MCC;

3. the geographic locations in and outside Alberta in which the corporation intends to provide services;

4. the projected rate structure for the cost of service; and

5. the market impact analysis of the New Waste Provider's provision of services.

TAKE NOTICE THAT due to the global COVID-19 pandemic, Council has elected to hold the public hearing via an electronic procedure. The following rules shall apply:

1. Hearing Deliberation: The electronic public hearing will be structured such that all who choose to participate, shall have the right to hear all discussions and those who have pre-registered, can make oral submissions;

Recycling at BMS

Recycling services for residents of Beaver County are available through Beaver Municipal Solutions' transfer stations. **Cardboard and paper** recycling is available

to residents and businesses of Beaver County. Cardboard needs to be flattened. If paper or cardboard is wet or soiled throw it away. Unfortunately, soiled materials contaminate the load and make recycling harder, or in some cases impossible. Must sort paper and cardboard.

Dedicated bins are located in Ryley, Holden, Lindbrook and at the Tofield Transfer Station and Viking Transfer Station.

Paint disposal for recycling is available at the Lindbrook and Viking transfer stations and the Ryley land-fill. Call to check paint types excepted.

Electronics can be recycled at the Lindbrook, Tofield, Ryley and Viking transfer stations. Recycle televisions, computers, servers, laptops, tablets, printers, copiers, scanners and fax machines.

Tires can be recycled at the Lindbrook, Ryley and Viking transfer stations. You can recycle car and light truck tires, medium truck tires, specialty tires (agricultural, atv, skid-loader, motorcycle, bicycle, lawn tractor, implement) and OTR (Off The Road) tires (mining, forestry, construction equipment). Tracks of any kind cannot be recycled. Foam filled or solid tires cannot be recycled (solid skid loader tires)

Oil, Filters and Containers can be recycled at the Lindbrook, Ryley and Viking transfer stations. Ensure that oil is not contaminated with other substances e.g. diesel, antifreeze, water etc. Only jugs and containers under 5L are recyclable under this program. The above recycling programs are facilitated through the Alberta Recycling Management Authority (ARMA). **Antifreeze** can be recycled at the Lindbrook, Ryley and Viking transfer stations.

Metals can be recycled at the Lindbrook, Ryley, Viking and Kinsella transfer stations.

Freon-Containing Appliances

Refrigerators, cold water dispensers and other freon containing appliances can be recycled at Lindbrook, Ryley, Viking and Kinsella transfer stations. There is a Freon removal charge of \$25 per appliance.

Automotive and Large Batteries can be recycled at the Lindbrook, Ryley, and Viking transfer stations. Included batteries include car, tractor, motorcycle, emergency lighting batteries and booster pack batteries (these have to be removed from the casing).
