#### Cr. Ducherer Comment on Regular Council Meeting of Dec 1, 2020.

After consideration of the last Regular Council Meeting of December 1, 2020, I listened to the livestream video feed on Facebook and made some notes...

During the discussion of COVID Contact Tracing, Cr. Lee made numerous false statements. Firstly, he outright lied when he stated at <23:03> that the CAO said: "...that information was being stored in an unsecured situation..." The CAO made no such statement and made no such suggestion. Cr. Lee said at <23:35> that it is not common practice for businesses to collect contact tracing information when it is quite common and a widespread practice throughout Edmonton, indeed throughout Alberta. Much like RPAC, Cr. Lee's characterization of events or situations when telling stories are often misleading, if not outright false. Cr. Lee seemed to be trying to prosecute the CAO for a failure to carry out proper practices to protect personal information. His hypothesis at <23:10> being that the CAO setting up a new box proves that information was being stored previously "in an unsecured situation", when he offered no information on how it was being previously stored in an unsecured manner. This was never established in the discussion aside from <22:40> "Grethe collected the information". His conclusions at <25:27> from the provided information are wild and false leaps of logical based on anecdotal ideas. Cr. Lee guite literally made things up as he went along, and those things all seemed to me to be focused on making the CAO look bad. To take his conclusions and to falsely quote the CAO is comparable to defamation of character. Taking this further, Cr Lee says at <23:15> that the CAO does not understand what he is doing under the FOIP Act. Again, this is suggestive and seems to me like an attempt to slander the CAO.

During the discussion of the Mask Bylaw, Cr. Lee takes issue at <31:10> with the CAO's inclusion of references to the Criminal Code and Sentencing in the Request for a Decision (RFD). After all other councillors stated that they were fine with the RFD, Cr. Lee disrespectfully took the Mayor to task at <31:50> and then he assumed a superior intellectual posture to the Mayor and Council (he does this again later at <39:40>). As a single voice in the discussion, he once again went rogue and hijacked proceedings. At <38:30> he would not let the discussion move forward, despite the efforts of all other councillors and despite a motion being on the table. As one councillor in the discussion, I took the CAO's reference in the RFD to mean that there are principles that could be considered for "sanctions" and the CAO brought forward an excellent reference to help us guide those considerations when talking about making masks mandatory. As he often does, Cr. Lee states at <34:50> that: "all of this will become very clear, very quickly" and at <39:40 & 44:30> Cr Lee continuously thwarts council discussion and tries to involve the CAO and the criminal code reference in the RFD when the remainder of council had already heard Cr. Lee's point at <42:25> and tried to move forward to discuss the motion on the table. A citizen while listening to this discussion on the livestream feed wrote in the comments at this time in the video: "why is every conversation that Cr Lee engages in an attack or a trap". At <45:34> I tried to remedy this because I interpret these outbursts and persistent pestering of the CAO by both Cr. Lee and RPAC as part of a campaign to discredit and defame the CAO. I suspect this is because the CAO will not let them get away with their games and time-wasting antics. Worse yet, showing particularly poor code of conduct, Cr Lee stated to a fellow councillor during this discussion at <46:20>: "I love it when you display the level of intelligence that you got".
