RECOMMENDED ACTION

That Council for the Village or Ryley directs administration to purchase the 4 cemetery plots, Block 30, Plots 1 to 4, back from the previous owners at \$325 each as offered.

Or

That Council for the Village or Ryley directs administration to purchase the 4 cemetery plots, Block 30, Plots 1 to 4, back from the previous owners at \$297.50 each.

BACKGROUND/PROPOSAL

The family purchased a section of 8 plots in the Ryley cemetery for their family in the distant past. They have used 4 of the plots and are in no need of the additional 4 that have not and will not be used by the family. They have requested that the Village purchase these 4 plots back at \$325 each. We have looked back in the older cemetery records we have and cannot find any record of purchasing the plots but did see multiple donations from this family to the cemetery.

Alberta Cemeteries Act

Resale of plot to owner of cemetery

25. If the owner of a cemetery sells a plot for a burial site and prohibits its resale on the open market and if the purchaser of the plot offers to sell the unused plot back to the owner of the cemetery, the owner of the cemetery shall

- (a) purchase the plot, and
- (b) pay a purchase price calculated in accordance with the regulations.

Alberta Cemeteries Act General Regulations

Calculation of resale price

2. For the purposes of section 25(b) of the Act, the purchase price of a plot shall be an amount representing at least 85% of the market value of the plot at the date of resale.

In accordance with the act and regulations the village shall purchase the plots back at least \$297.50 each which is 85% of \$350, the current plot cost. Administration recommends \$325 each.

\$325 per plot for a total of \$1300

AND WHEREAS the *Emergency Management Act*, R.S.A. 2000, Chapter E-6.8, with amendments thereto, requires the municipality to direct and control its emergency response;

AND WHEREAS under the provisions of the *Municipal Government Act*, R.S.A. 2000, Chapter M-26, municipalities may request that the Lieutenant Governor in Council establish a regional services commission to provide services otherwise being provided by municipalities, in this case fire protection and emergency management services;

AND WHEREAS, the Municipal Council of the Village of Ryley deemed it expedient to provide fire and emergency management services in conjunction with neighboring municipalities through a regional services commission and with Beaver County, the Towns of Tofield and Viking, and the Village of Holden, made application for the Lieutenant Governor in Council to form a Regional Services Commission for the purpose of providing fire and emergency management services in and to the member municipalities;

AND WHEREAS on April 29, 2010, the Beaver Emergency Services Commission was established by O.C. 137/2010;

AND WHEREAS The Village of Ryley wishes to formally recognize that the Beaver Emergency Services Commission will be providing fire and emergency management services in the Village of Ryley and wishes to give full force and effect to the O. C. 137/2010;

NOW THEREFORE BE IT RESOLVED that the Municipal Council of the Village of Ryley, in the Province of Alberta, duly assembled, enacts as follows:

1. DEFINITIONS

1.1. "Apparatus" means any vehicle provided with machinery, devices, equipment or materials for emergency use, as well as any vehicles used for transporting firefighters or supplies;

- 1.2. "Chief Administrative Officer" means the chief administrative officer of the Village or their delegate;
- 1.3. "Councilors" means those members on Council for the Village;
- 1.4. "Disaster Recovery Regulation" means the Disaster Recovery Regulation, Alta Reg 51/1994, as amended from time to time;
- 1.5. "BESC" means the Beaver Emergency Services Commission;
- 1.6. "**EMA**" means the *Emergency Management Act*, RSA 2000, c E-6.8, as amended from time to time:
- 1.7. **"Emergency Management Agency"** means the agency that is responsible for the administration of BESC's emergency program;
- 1.8. **"Equipment**" means any tools, contrivances, devices, or materials used by the Fire Services Department that may be applied at an emergency incident;
- 1.9. "False Alarm" means an emergency call which is activated accidentally or maliciously that does not require any services from BESC's fire personnel;
- 1.10. "Fire Services Department(s)" means the Fire Services Department(s) established by BESC's Establishment and Operation Bylaw, which each include a Fire Chief, Assistant Fire Chief(s), Firefighters, and any person duly appointed to this department by the Board of Directors of BESC, together with all Equipment and Apparatus, including fire stations established to prevent, extinguish, and investigate the cause of fires, to preserve life and property from injury or destruction by fire;
- 1.11. "Incident" means a fire, a situation wherein a fire or explosion is imminent, or any other situation presenting a fire or possible danger to life, property, or the environment, and to which BESC has responded. For clarity, such situations can include transportation accidents, hazardous materials releases, or potential releases, medical assists, or any life threatening situation;
- 1.12. "Joint Quality Management Plan" means that quality management plan between BESC and the Alberta Safety Codes Council accrediting BESC to administer the provisions of the *Safety Codes Act*, RSA 2000, c S-1, as amended from time to time:
- 1.13. "MGA" means the *Municipal Government Act*, RSA 2000, c M-26, as amended from time to time; and
- 1.14. "Village" means the Village of Ryley.

2. DELEGATION OF POWERS

2.1. The Village hereby delegates the provision of fire protection and emergency management services within its municipal limits to BESC. The Village further appoints BESC to act as its agent in the recovery of fees incurred as a result of

BESC extinguishing a fire, responding to an Incident, or responding to a False Alarm. The Village further appoints BESC to act as its Emergency Management Agency. Without restricting the generality of the foregoing, the powers being delegated include:

- 2.1.1. providing fire protection services;
- 2.1.2. investigating the cause of fires in accordance with the Alberta Fire Code and the Joint Quality Management Plan;
- 2.1.3. providing a first responder level of response to Incidents involving dangerous goods;
- 2.1.4. monitoring and amending the Joint Quality Management Plan as required;
- 2.1.5. entering into mutual aid agreements with other municipalities, agencies or persons to provide assistance in controlling an Incident;
- 2.1.6. purchasing and operating Apparatus and Equipment deemed necessary for the preservation of life and property;
- 2.1.7. directing and controlling the municipality's emergency response;
- 2.1.8. preparing and approving the emergency plans and programs;
- 2.1.9. contracting and/or entering into agreements with other persons or organizations for the provision of services in the development or implementation of emergency plans or programs;
- 2.1.10. administering the appointment to and supervision of an emergency advisory committee;
- 2.1.11. fulfilling all duties and responsibilities of an emergency management agency:
- 2.1.12. declaring and terminating any local states of emergency, including the publication of the details of the declaration, termination or cancellation;
- 2.1.13. exercising all powers granted to a local authority under section 24 of the EMA including the power to borrow under subsection 24(2);
- 2.1.14. making application to the Government of Alberta for compensation incurred in conducting emergency operations under the Disaster Recovery Regulation, as amended from time to time;
- 2.1.15. recovering the costs and expenses of fighting a fire within the jurisdiction of the Village;
- 2.1.16. issuing orders concerning fire hazards and burning hazards, including taking all measures necessary to enforce those orders and recover any costs associated with their enforcement; and

2.1.17. issuing, cancelling and suspending fire permits, including attaching any conditions it deems advisable to any and all permits.

3. TRANSFER OF CHATTELS

3.1. The Village transfers the legal and beneficial ownership in all the Apparatus and Equipment which it owns that are specifically mentioned in O. C. 137/2010 to BESC.

4. TRANSFER OF REAL PROPERTY

4.1. The Village transfers the legal and beneficial ownership in the lands and buildings which it owns that are specifically mentioned in O. C. 137/2010 to BESC.

5. EFFECTIVE DATE

5.1. BESC shall have the right to exercise the powers referred to herein, in accordance with section 3 of the O. C. 137/2010, from the date of its inception.

6. ASSIGNMENT OF MUTUAL AID AGREEMENTS

6.1. The Village hereby assigns all of its rights, responsibilities and duties under any current Mutual Aid Agreements with any other municipalities, Her Majesty the Queen in the right of the Province of Alberta and/or any other entities to BESC.

7. CESSATION OF FIRE HALL OPERATION AND FIRE RESOURCES AGREEMENTS

7.1. The Village hereby declares that, effective as of the inception date of BESC, all Fire Hall Operation and Fire Resource Agreements and all Fire Truck Agreements previously entered into with the BESC member municipalities cease to be effective and are hereinafter null and void.

8. FIRE PERMITS AND FIRE PITS

- 8.1. No person shall light an outdoor fire or structure fire unless the person has: been issued a fire permit by BESC on such terms and conditions as BESC in its sole discretion considers appropriate.
- 8.2. All fire pits shall be required, at all times, to comply with the standards, policies, and/or regulations as established by BESC, as amended from time to time.

9. FIRE BANS

9.1. BESC shall be solely responsible for declaring and repealing all fire bans affecting the Village.

10. RECOVERY OF EXPENSES

- 10.1. The owner of a property is liable to the Village for all expenses and costs related to the Village, through its agent, BESC, extinguishing fires on the property.
- 10.2. A person who causes a fire is liable to the Village for all expenses and costs related to the Village, through its agent, BESC extinguishing the fire.
- 10.3. The Village, through its agent, BESC, may seek recovery of expenses and costs in this Part either jointly or severally.
- 10.4. Any unpaid costs and expenses for extinguishing fires on a parcel of land may be added to the tax roll for that parcel in accordance with Subsection 553(1)(g) of the MGA.

11. REPEAL OF EXISTING BYLAW

11.1. The following Bylaw of the Village is hereby repealed in its entirety:

11.1.1. Bylaw No. 2011-897





RE: Cancellation of Household Hazardous Waste Funding

Dear Minister Panda,

Under the Town of Rocky Mountain House Strategic Plan, Council is committed to being an environmental leader. Our municipality has focused on waste reduction and diversion, with the notable recent achievements of opening the Town of Rocky Mountain Eco Centre and launching a residential curbside organics collection program. Our 6,800 residents have embraced these programs and households are taking careful stewardship of their waste.

It is in this context that we were disappointed to learn the Government of Alberta ceased disposal funding for the provincial Household Hazardous Waste (HHW) program as of June 1, 2021. Alberta Environment and Parks' grant provided for the safe collection and transportation of these goods, while Alberta Infrastructure waived disposal fees at the Swan Hills Treatment Centre.

This action burdens municipalities with a \$2 million annual cost to safely dispose of HHW. Given the financial strain on municipalities affected by the global pandemic, this decision by the Alberta Government will force Albertans to take a step backwards in responsible waste disposal.

The Town of Rocky Mountain House urges you to take a long view of responsible waste management. With the pending transition to Extended Producer Responsibility (EPR) in Alberta, we encourage you to reinstate Alberta Infrastructure funding for municipalities to offset cost of disposal. Alternatively, the Government of Alberta should expedite the implementation of EPR for HHW to mitigate this unexpected financial burden on municipalities.

Dear Mayor Magneson:

On October 18, 2021, the Government of Alberta intends to conduct a provincewide election of nominees for Canada's Senate, as well as a referendum. Senate and referendum voting will be conducted alongside the general municipal election. To support local governments administering these votes, the Senate Election Grants Regulation under the *Alberta Senate Election Act* and Referendum Payments Regulation under the *Referendum Act* require the Minister of Municipal Affairs to make payments to the local authorities that are administering the votes.

The regulations state:

- where an election under the Local Authorities Election Act is required in a municipality or ward, the elected authority or other body that conducts the vote under the Alberta Senate Election Act or Referendum Act in that municipality or ward shall be paid a grant of \$1 per capita or \$1,000, whichever is greater; or
- where no election under the Local Authorities Election Act is required in a municipality or ward, the elected authority or other body that conducts the vote under the Alberta Senate Election Act or Referendum Act in that municipality or ward shall be paid \$2 per capita or \$2,000, whichever is greater.

Given there will be both senate elections and referendum questions occurring as part of the 2021 municipal general election, municipalities holding local elections will be eligible for a grant of \$1 per capita or \$1,000 (whichever is greater) for the senate election vote and \$1 per capita or \$1,000 (whichever is greater) for the referendum for a total interim grant of \$2 per capita or \$2,000 (whichever is greater).

Should it then later be determined that a municipality does not need to hold a local election, the municipality will then be eligible for an additional grant of \$1 per capita or \$1,000 (whichever is greater) for the senate election vote and \$1 per capita or \$1,000 (whichever is greater) for the referendum for a total combined grant of \$4 per capita or \$4,000 (whichever is greater).

Based on this formula, and to streamline the process, the **Village of Ryley** will receive an initial grant payment of **\$2,000** in August to conduct the 2021 Senate election and referendum. If a local election is not held under the *Local Authorities Election Act* in the **Village of Ryley** on October 18, a second payment of **\$2,000** will be made in October.

If the Senate election and/or referendum are cancelled, the **Village of Ryley** will be required to return the initial grant payment to the Government of Alberta, if requested by the province.

Some municipalities may be administering the Senate election and referendum on behalf of the Minister of Municipal Affairs for a neighbouring entity, and will receive the payments calculated for the neighbouring entity. These municipalities will receive a separate letter confirming the additional amounts once the contracts are finalized.

Conducting the Senate election and the referendum at the same time as local elections will leverage efficiencies and economies of scale, while ensuring all Albertans have the ability to participate in the vote.

Thank you for your work in strengthening democracy in Alberta.
